DECLARATION CARD**

CUSTOMS AND BORDER CONTROL POLICY DICTATES THAT PERSONS WITHIN THEIR DUTY FREE ALLOWANCES ARE NOT REQUIRED TO COMPLETE THIS FORM; SUCH PERSONS MAY PROCEED THROUGH THE FREE FLOW CHANNEL UPON ENTRY. PLEASE SEE REVERSE SIDE FOR INFORMATION ON ALLOWANCES.

IMPORTANT INFORMATION

Declaration - Passengers over their allowances are required by law to declare all articles in their possession. "Declaration" means your written and physical representation of circumstances purported to be factual for the purpose of the Customs and Border Control clearance process.

Cayman Islands Residents - must declare the total value of all articles acquired abroad (whether by purchase, as a gift or otherwise) which are in their or their family's possession at the time of arrival.

Visitors to the Cayman Islands - must declare the total value of all gifts, foods, spirits, liquor, tobacco products and any articles which they are intending to leave or consume in the islands.

Duty - Customs and Border Control Officers will determine the amount of duty to be paid, based upon the value declared and in accordance with the appropriate tariff.

Duty Free Allowances - Cayman Islands Residents returning from a visit overseas may bring with them dutiable or household articles, at the discretion of the Director, up to the value of CIS\$500.00/(US\$595.00). In addition, all passengers over the age of 18 years may bring with them the following items:

- Up to 1 litre of portable spirits; or
- 1 case (not exceeding 8 litres) of beer; or
- 4 litres of wine;
- Up to 200 cigarettes; or
- 250 grammes tobacco; or
- 25 cigars; or
- 100 cigarillos

The transportation of "Currency" and other "Negotiable Monetary Instruments" regardless of the amount is legal. However, if you bring into the Cayman Islands Currency and other "Negotiable Monetary Instruments" valued CI\$10,000 or more, or foreign equivalent, or a combination of both, you must declare it and you must also file additional particulars with Customs and Border Control on the form provided.

"Currency" means cash or negotiable monetary instruments.

"Cash" means bank notes or coins that are legal tender in any country whether or not convertible.

"Monetary Instruments" include non-cash instruments such as cheques, traveller's cheques, promissory notes, money orders or postal orders or bearer negotiable instruments including such form as those mentioned. The "bearer" is the person in possession of the negotiable monetary instrument. Monetary instruments may also include in such form as those mentioned any which are endorsed without restriction, made out to a fictitious payee, or otherwise in such form that title thereto passes upon delivery; or it may be an incomplete instrument which is signed but with the payee's name omitted.

"Bullion" is gold, silver, or other precious metals in the form of coins, ingots, or bars. Although bullion is not a monetary instrument for purposes of this requirement, it still must be declared upon entry.

Failure to make such declaration for the total amount you are carrying may result in the seizure of all the Currency or negotiable monetary instruments, and may subject you to civil penalties and/or criminal prosecution.

FAILURE TO MAKE A FULL DECLARATION IS AN OFFENCE AND CAN RESULT IN THE FORFEITURE OF THE GOODS, FINES AND/OR IMPRISONMENT

Prohibited or Restricted Goods

The importation of controlled drugs and utensils used therewith is absolutely prohibited. The importation of spear guns, Hawaiian slings and parts etc., is prohibited. The importation of firearms and ammunition is prohibited unless accompanied by a permit signed by the Commissioner of Police, Cayman Islands.

Agricultural Products

Certain items brought into the Cayman Islands are restricted by the Department of Agriculture. All travelers are required to declare any fruits, vegetables, meats, plants, plant products, live animals, animal products, and aggregate material. These items may be imported only if the owner is in possession of a valid permit issued by the Cayman Islands Department of Agriculture.
